Director's Note...

The Downtown Dover Partnership had an exciting year. In the fall of 2011 we solicited bids for the renovations at 22-24 W Loockerman that would create two first-class retail spaces. The front and rear facades were also updated and this prime retail space will be available for rental in the fall of 2012.

Our Community Art Project was launched by the Design Committee to draw attention to Dover's new Brand. More than 30 local and regional artists of all ages participated in the project by decorating Stars which were then auctioned off to raise funds for future Design Committee Projects. The second year of the Community Art Project is now underway. We also completed a redesign of the information panels on the kiosk in the Bradford Street Parking Lot and a second kiosk will be erected in the new parking lot on Loockerman Way with visitor information for Delaware's Capital City.

May 15, 2012 saw the DDP break ground on the North Street Area Improvements funded by the Delaware Legislature in 2011. The Downtown Dover Partnership purchased the former Collegian Property and received a parcel of land from the City of Dover to create a plaza in the heart of downtown. Loockerman Way Plaza will provide a stronger pedestrian connection between Loockerman and North Streets. It will also provide an additional thirty-six (36) short-term parking spaces for visitors to the downtown. The utility work on North Street which involves the burial of all communication cables and removal of the poles is nearly complete and construction of Loockerman Plaza has begun. Other North Street Area improvements to be completed as part of

the project include: North Street surface parking consolidation to combine six (6) separate parking lots and yield additional parking; and North Street streetscape improvements to create a pedestrian friendly corridor to the capital complex.

As we begin our fifth year of operation we look forward to continuing our redevelopment and revitalization efforts and the creation of positive change and economic growth in Historically Happening Downtown Dover. We're counting on your continued support and participation as we work to meet our ambitious goals during the next year. Downtown Dover is on the move!

Increasing Competitiveness of Downtown Businesses

In our efforts to support both existing and potential businesses in the downtown, the DDP hosted seven (7) Business Development Workshops that provided information on marketing techniques, developing a business plan, loan seminars, social media, e-commerce, and other topics that were attended by 160 individuals.

Business Assistance Provided
