## **Annual Report**

In **January 2023**, the Downtown Dover Partnership received the final master plan, **Capital City 2030: Transforming Downtown Dover!** An ambitious series of implementation outcomes followed throughout the year:

**Implementation projects were already underway with the DDP's Critical Improvements Program** in which \$1.2M was allocated toward business district projects that, once completed, will result in ADA and life safety improvements, several apartments, and new commercial kitchens to bring eateries needed to support a thriving business district.

On **March 22**, over 200 people attended a **public presentation of the plan** at Kent Levy Court and virtually. The plan, developed by the Mosaic Development Partners team with engagement of over 800 community members and thought leaders, has been received enthusiastically by the community!

By **July 1**, DDP signed a contract with Dover Kent MPO (Metropolitan Planning Organization) to complete the **Downtown Dover Pathways Study**, to better connect key activity centers within the Capital City.

By Labor Day, Property Development Director, Ken Anderson, was hired, fulfilling a key DDP priority to secure most qualified candidate to oversee site-readiness and redevelopment of three large scale DDP-owned sites.

By **October 30**, two crosswalks were painted by community members and new light post banners featuring local artwork were installed, **adding vibrancy downtown through "placemaking."** 

On November 20, DDP received word that the EPA accepted DDP's Environmental Assessment Grant application.

On **December 11**, the **Binding Memorandum of Understanding was signed** for 120 S. Governor's Ave. redevelopment between Mosaic Development Partners, Colonial Parking Inc., and the Downtown Dover Partnership.

**Private investment is being spurred** by the final plan and commensurate activity, including selection of developer by the City of Dover to redevelop the former post office site, to include 30 market-rate apartments, two commercial spaces and on-site parking. We anticipate this kind of private investment will continue.

2024 holds plans for continued, aggressive implementation of the plan. The transformation has begun!

## What will people begin to see?

Those visiting, working, and living downtown will begin to see significant, visible change – a glimpse of things to come - in the downtown business district due to implementation of the master plan.

Amidst jackhammers, excavators, bucket trucks, bulldozers, street sweepers, and the like, they will also see a reduction in commercial building vacancy, increased foot traffic, road infrastructure and transportation improvements, including a parking structure, as well as preparations for 200 new residents (toward goal of 2000) in multi-story buildings, alternative modes of getting around the city, and color and vibrancy in the district.

# 2024 On the horizon!

Throughout 2024 and into 2026, DDP will focus on six major projects of the Capital City 2030 strategic plan, several of which will utilize \$25M in State funds allocated to DDP and the City of Dover:

- 1. Implementation of underground infrastructure improvements to support planned redevelopment by City of Dover.
- 2. A **multi-modal transportation hub** will be constructed, featuring a parking garage, bike share, and micro-transit bus services that will provide for transportation needs of the community, including residents, workers, and visitors. Planned completion 2026.
- 3. DDP's priority redevelopment project with Mosaic Development Partners and Colonial Parking at 120 S. Governor's Ave. will be nearing completion. This project lies in the heart of downtown and plans include a six-story, mixed-use complex with approximately 160 residences and ground level small-scale, full-service grocery, coffee shop, fitness center, and daycare center.
- 4. The now underway **Critical Improvements Program** will support approximately \$6M in public/private investment for retrofits to existing buildings in the central business district.
- 5. Completion and implementation of the **Downtown Dover Pathways Plan via Dover Kent MPO** will better connect key activity centers and downtown anchors (Bayhealth, DSU, the State of Delaware, and DAFB) facilitating a more walkable district, and will include bike, scooter, and micro-mobility options.
- 6. Build on success of several **creative arts/placemaking initiatives** toward ongoing public arts programming, including additional painted **crosswalks**, a **community art walk and performance amphitheater**.
